

This healthcare company offers a wide range of healthcare services. At the core of their operations is a variety of files and databases, like PostgreSQL database and MySQL Server.

This landscape, while powerful, poses challenges in data management, protection, synchronization, and regulatory compliance. Effectively managing these complexities demands a flexible and robust solution like the ADM platform. Less capable data masking solutions are unable to manage complexities of billions of rows across multiple data sources. ADM provides comprehensive data discovery and masking capabilities across multiple databases and data sources, addressing the company's needs for efficient, secure management of diverse data assets while ensuring adherence to stringent industry regulations like PII and HIPAA.



Challenges

Embarking on its digital transformation journey, the healthcare company faced the obstacle of the **nuanced Postgres database** and the **referential integrity of various data sources**.

The Postgres database is uniquely challenging because it automatically updates indexes. When this updating occurs during data masking, it can greatly increase processing times. To prevent this delay, the Accutive Security team suggested that the healthcare company remove the indexes during the data masking process and reinstate them afterward. Unfortunately, the indexes were not removed correctly, significantly delaying the initial data masking process.

Fortunately, the Accutive Security team was able to identify the issue and dramatically reduce the processing time from three weeks to less than a single day. Although one day was still substantially longer than ADM's typical masking operation time, it was significantly faster than alternative masking methods. Moreover, the healthcare company gained valuable insight into the functions of its database and is now better prepared for future data masking and automation projects.

Another obstacle faced by the healthcare company was the need for referential integrity across different data sources. The company uses one database and two types of files; however, in one file, data is uniquely formatted. If not addressed, this can lead to masking errors and compliance failures.

Fortunately, the Accutive Security team was able to resolve the issue by writing custom groovy scripts for the healthcare company. These groovy scripts addressed the discrepancies between data format types and allowed data masking to continue successfully. As a result, data represented in multiple data sources was efficiently and identically masked regardless of location.
